Challenge

As a global platform, Flirtback needed to support different ID documents, which resulted in variations of different languages, rare formats, and additional time and costs.

The previous manual approach to KYC was timeintensive, prone to human error, and increased the risk of fake profiles, which was an unwanted threat to the platform's integrity.

Without a more advanced solution, Flirtback's team struggled to onboard creators swiftly while maintaining the necessary standards.

This gap resulted in onboarding delays and unnecessary frustration for new creators waiting in line to join the platform.

To support growth and different market requirements, including country-specific regulations, platform Flirtback needed a custom-tailored approach to user onboarding.

The company needed a solution that combined easy access for new users with strict safety and verification standards.


Flirtback chose iDenfy's Al-powered identity verification solution, which uses both government-issued ID document checks and biometric verification powered with liveness technology.
